Covid-19 Update

Rob Simonds, CAO, presented an overview of initiatives being taken or considered with regards to Covid-19 and the reopening of County offices. Weekly extended management meetings are ongoing, and staff are continuing to modify work practices as well as create and revise policies with regards to Covid-19.

A committee has been formed to look at how the Municipality will reopen in a safe and functional way for both staff and the public. Michelle Newell, Director of Public Works, provided a summary of topics being discussed at the committee meetings including looking at employee workspace setups, review of our disinfection process, discussion with the Courts on their

reopening and the lead time we will have to implement any changes necessary.

Community Relief Initiatives Update

Mr. Simonds provided an update on the clean-up from the Dangerous and Unightly report that was filed stating that the work is almost complete. The Municipality continues to receive condolences and donations for the families involved.

Funds

Discussion was held on the donations being received by the Municipality for the victim's families including what program they will go to and how we handle them in the meantime.
